### 4. Waiver of Negligence and Release of Liability

I/we wish to participate in the Just 'Cause We Can Walk, which I/we understand to be approximately a 3.5 mile, non-competitive walk. I/we understand that by participating in the Just 'Cause We Can Walk, I/we will be using public streets & facilities where many hazards exist & I am/we are aware of & appreciate the risks, which may result. I am/we are also aware that accidents can occur & that I/we may be seriously injured or killed as a result. I am/we are voluntarily participating in this event with knowledge of the dangers involved & I/we agree to accept all risks of injury or death.

In consideration for being permitted to participate in the Just 'Cause We Can Walk, I/we agree to assume all risks and to release and hold harmless all sponsors, beneficiaries, affiliated organizations, officials, clubs, communities, directors, officers, agents & members of Bolton Walkers Inc., a 501(c)3 non-profit organization under the IRS, & Just 'Cause & Just 'Cause We Can Breast Cancer Walks, all government or public entities (& all of their respective officers, directors, agents, employees, & members) of the Commonwealth of Massachusetts, & the Massachusetts Department of Transportation.

I/we intend by this Waiver & Release to release, in advance, & to waive my/our rights & discharge all the persons & entities mentioned above, from any & all claims for damages for death, personal injury or property damage which I/we may have, or which may hereafter accrue to me/us as a result of my/our participation in the Just 'Cause We Can Walk, even though that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective property or equipment owned, maintained or controlled by them or because of their possible liability without fault. I/we understand & agree that this Waiver & Release is binding on my heirs, assigns, & legal representatives.

I am/we are physically capable to participate in the Just 'Cause We Can Walk, & I/we acknowledge that I am/we are solely responsible for the personal health & safety, & the personal property I/we bring with me/us.

I have carefully read this Waiver and Release and fully understand its contents. I certify that the primary person signing is at least 18 years of age at the time of the event. I am (we are) aware that this is a Release of Liability and a contract between me (us) and the persons and entities mentioned above and all the respective officers, directors, agents, and representatives and I (we) sign it of my own free will.
